REGULAR MEETING  
March 14, 2007

CALL TO ORDER

Supervisor Kenneth Parrigin called the regular meeting to order at 7:00 p.m. at the Coloma Charter Township Hall, Coloma, Michigan. Present for the Township: Supervisor Kenneth Parrigin, Clerk Debra Olsen, Treasurer Lance Becht, Trustees Edward Helbling, Brian Duffield and Cynthia Aviles. Absent Trustee Robert Molter. The Pledge of Allegiance was led by Supervisor Parrigin.

CONSENT AGENDA

Treasurer Becht presented the consent agenda. Treasurer Becht reported that the finance committee met and approved bills totaling \$140,154.45. Moved by Treasurer Becht, seconded by Trustee Helbling to approve the consent agenda and finance report. VOICE VOTE: ALL AYES. ONE ABSENT. MOTION CARRIED.

PRESENTATIONS AND ANNOUNCEMENTS

Deanna Heminger gave a presentation regarding the Silver Beach Carousel Society. They are raising money to purchase a Coloma Comet Horse for the Carousel.

Bill Moser informed the board the Joint Fire Board solicited bids for a new fire truck and accepted a bid for \$262,688.00. Bids were also solicited from banks to obtain a loan for the fire truck. Chemical Bank gave the lowest interest rate of 4.34%. The loan will need to be secured through Coloma Charter Township or Hagar Township. Coloma City and Hagar Township have already approved the purchase of the fire truck.
