COMMITTEE REPORTS

Trustee Rob Harper stated the Fire Department responded to 26 fire runs in April. They are remodeling the men's bathroom at Station 1. There was some clean up at Station 2. Also completed yard clean up, repainted safety posts outside the bay doors, and made several minor repairs to the trucks. Trustee Jim Fulton stated there was a public hearing for a special land use permit which will be discussed under new business.

Treasurer Lance Becht presented the April Summary for the Paw Paw Lake Area Wastewater Plant. Coloma had the highest percentage at 37%. The SAW grant will be officially awarded in May. There was discussion with the Board which projects will be done first. Also discussed process of submitting costs of projects for payment. Grant money must be used within three years. The plant audit began in early May. They will purchase a new balance for the lab. The plant is in compliance.

Chief Pompey presented his monthly activity report and highlighted some of the items in his report. Total complaints investigated for the month was 248. He informed everyone the Lane Automotive cruise in will be May 23, 2014 and the Police Department will be assisting as the vehicles pass through Coloma. He announced there will be a motorcycle poker run on May 25, 2014, sponsored by the South Haven American Legion, which will pass through Coloma and the Police Department will also be assisting.

Trustee Matt Moser informed everyone a member of the Cemetery Board had moved out of the area and the Board would need to find a new member.
