Chana Kniebes announced the North Berrien Community Development will not be collecting 4th quarter payments from municipalities.

Treasurer Becht announced the sewer board is reviewing the employee health insurance. They are also looking at a proposal for a generator for pumps at the sewer plant.

Clerk Olsen reported the committee appointed to look into purchasing the property located at 5408 Paw Paw Lake Road has decided not to pursue the issue.

Moved by Trustee Molter, seconded by Treasurer Becht, to approve the maintenance agreement between Coloma Charter Township and the City of Coloma for maintenance of the entire sewer system and lift stations for a fee of \$80,000.00 annually and to authorize Supervisor Parrigin to enter into a contract stating such.
